

## TERMS & CONDITIONS

### ANNUAL WEBEXTRA PROGRAMME

1. In these terms and conditions Rezidor Cornerstone A/S is referred to as we, us or our, as the case may be, the applicant contracting for the WebExtra site is referred to as you or your, as the case may be, and the site is the Radisson Blu or Park Inn by Radisson website generally and your WebExtra site.
2. The Annual Hotel WebExtra Programme is a mandatory programme for the hotel of the Rezidor hotel group.
3. After your submission, the Agreement will be of an indefinite period. Rezidor Cornerstone A/S may terminate this agreement without reason with a notice period of 4 weeks by written notice. Fees are subject to change by Rezidor Cornerstone A/S.  
The Annual Service Plan (ASP) includes an amount of 150 credits for each hotel. Each request is equal to one credit, e.g. one photo = 1 credit, one text insertion = 1 credit, one pdf = 1 credit. Creating a new page will count as one request plus each additional component on the page.  
The ASP includes an annual review where content are re-evaluated and edited to enhance visitor appeal as well as search engine rankings.
4. New hotels (defined as hotels that do not currently have a WebExtra site) must execute the Agreement prior to the hotel's on-line date, and the WebExtra site should be active within 30 days of going online with the reservation system.  
New hotels in the first year of the Agreement are responsible for and required to pay the one-time pre-opening site fee (if applicable), development fee together with the Annual Service Plan (ASP) fee. The ASP fee will be prorated on a daily basis for the balance of the contract year.
5. We cannot be held responsible for any content of your WebExtra site, hereunder fault language, discrimination, cultural differences. All content must be according to local law. You are responsible for all information supplied and any statements of fact. We and third-party content providers make no guarantee of the accuracy, correctness, or completeness of any information on the site and are not responsible for (i) any errors or omissions arising from the use of such information; (ii) any failures, delays, or interruptions in the delivery of any content or services contained within the site; or (iii) losses or damages arising from the use of the content or services provided by the site.
